## **Eligibility & Requirements**

To be eligible, applicants must either reside in Oakland County or work for an Oakland County agency; proceeds may be used to defray the cost of college tuition or of earning a professional insurance designation, such as CIC, CPCU, AIA, etc. If the applicant is employed by an Oakland County agency, that agency must be a member of the IIAOC. Eligibility does not extend to agency principals.

In addition, each applicant must submit the following:

- A completed/signed MI Future Scholarship Application (This form grants MI Future the right to publicize and print any or all of the student's entry and/or photograph).
- Two (2) letters of recommendation from two (2) of the following sources: academic advisor, counselor, teacher/professor, employer or insurance professional. Applications will not be processed until recommendation letters are received.
- A one to two-page essay summarizing your career goals, academic accomplishments, work experience, pertinent extracurricular activities, why you are applying for this scholarship, and why insurance is your career of choice.
- A copy of current school transcript which includes grade point average to date. Also, please attach a copy of your résumé if available.
